### 2. The Quota :-

#### (a) Non-monority Colleges

- (i) 15% Seats:- Management Quota in non minority colleges

#### (b) Minority Colleges

- (i) 50% Seats :- Minority Quota includes Management quota (i.e. 15%) (in case college has been granted minority status)
- (ii) of remaining 50% seats, 50% seats for reservations as indicate at Sr. No. (1) students and 50% for Open category students
- (iii) In house Students be admitted first as per practice followed in the preceding years for admission to F.Y.B.A./B.Sc./B.Com. classes only.

(iv) Fees :- Strictly as prescribed by the University. Further, fees of Rs. 120/- be charged from Backward class students as per Circular No. वि.क./भासणि(२४)/३६० / २००४, दिनांक २५.८.२००४. Attention to the Circular No. वि.क./भासणि(२४)/ २८३/२००५, दिनांक ११.७.२००५ is also invited in this regard.

(v) No. College/s shall conduct its own CET or Test for admission to any course of University unless it is an autonomous college

Vacant reservation seats should be indicated on notice board and to be converted as per the prescribed procedure.

They are further informed that the communication regarding Centralized Admission Co-ordination Cell for admission to the Students deprived / unable to seek admission at the F.Y.B.A., F.Y.B.Sc & F.Y.B.Com. etc. classes during the academic year 2013-2014, will be issued separately.
